MEMBERSHIP APPLICATION INSTRUCTIONS

- Fill out the form. Applicants for Membership must be at least 18 years of age and applicants for Youth Membership must be at least 7 years of age.
- The applicant must subscribe in writing to both pledges on this application. No applicant shall be deemed to be a member of this Club until they have signed the pledges.
- The applicant must be endorsed and recommended by a member of the Club in good standing who vouches for the character, reputation and sportsmanship of the applicant. The applicant's sponsor must sign the application form.
- The applicant must supply proof of current National Rifle Association (www.NRA.org) membership in the form of **an applicant's NRA magazine label** or a **legible copy of the applicant's NRA membership card**, showing current membership and expiration date.
- **Mail the completed application along with the initiation fee, dues, and proof of current NRA membership to the Club's PO box, or hand it to the Secretary at a monthly Club meeting.**

After the application has been received, processed and approved by the Club, the applicant will be given instructions on signing up for the required New Member Range Orientation. Unless a waiver is granted, applicants are expected to complete Orientation within three (3) months after approval of their application. Applicants must complete the New Member Range Orientation before beginning Probation or using the range facilities.

After completing Orientation, Probationary members are required to attend 3 monthly Club meetings or Work Parties within the first six (6) months after Orientation, **signing in as Probationary**. Meetings are held on the 4th Tuesday of each month except December at 7:30 pm at Sundean Hall, 1032 Cayuga Street in Santa Cruz.

All club members, except those exempt for age (65 or older) or disability, are also expected to attend at least one work party during the year or pay a \$75 Work Party assessment. Work parties are announced in the Newsletter and are held on the 4th Saturday of each month from April through October at 9 am at the range.

After attending the required three meetings, Probationary members are eligible to receive their Welcome Letter and Club Membership Card at the next meeting they attend. Probationary members **must be present at the meeting** to receive their membership.
